CHUCK @ 925 VERY EARLY TAX CHEQUE RULES

THE CHUCK @ 925 VERY EARLY TAX CHEQUE CONTEST (THE "**CONTEST**") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ALBERTA AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ALBERTA OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "**CONTEST RULES**").

- 1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of Alberta;
 - (b) be of the age of majority or older at the time of entry; and
 - (c) live within fifty (50) kilometer radius of the City of Edmonton.

Employees of Corus Radio Inc. operating CKNG-FM (the "Station") and its parents, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, the "Sponsors"), advertising and promotional agencies, any person who has been confirmed as a winner of any previous Station administered contests within thirty (30) days preceding the Contest start date indicated below where the prize was valued over one-thousand Canadian dollars (CDN\$1,000.00), and/or the household members of any of the above are not eligible to enter.

2. CONTEST PERIOD. The Contest begins at 8:00 a.m. Mountain Time ("MT") on January 4, 2021 and ends at 11:50 p.m. MT on February 26, 2021 (the "Contest Period") after which time the Contest will be closed and no other entries shall be accepted.

3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (i) To enter online, complete and submit the entry form located at <u>https://chuck925.com/contests/</u> (the "Contest Website") together with the correct daily code word posted on the Contest page (the "Code Words", each a "Code Word") to be eligible to enter the draw. There will be nine (9) Code Words posted daily at 8:00 a.m., 9:00 a.m., 10:00 a.m., 11:00 a.m., 12:00 p.m., 1:00 p.m., 2:00 p.m., 3:00 p.m., and 4:00 p.m. MT.
- (b) Limit of one (1) entry per person per Code Word. In the case of multiple entries, only the first eligible entry will be considered.

- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. - (c) Prizes will be distributed within sixty (60) days after each Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

(a) On each of January 11, January 18, January 25, February 1, February 8, February 15, February 22, and March 1, 2021 in Edmonton, Alberta, one (1) entrant will be selected by a random draw from all eligible entries received by 11:59 p.m. on the Friday immediately preceding the draw date. Entries do not rollover to subsequent draws. Each entrant shall be eligible to win only one (1) Prize. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical

or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).

- (b) The odds of being selected as a potential winner are dependent upon the number of eligible entries including the correct Code Word received by the Sponsors.
- (c) EACH SELECTED ENTRANT WILL BE NOTIFIED BY E-MAIL NO LATER THAN MARCH 2, 2021 AT 5:00 P.M. MT AND MUST RESPOND WITHIN FIVE (5) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. - **13. TERMINATION.** The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations.
