BASS PRO SHOPS AND CABELA'S \$10K HOLIDAY HAUL CONTEST RULES

THE BASS PRO SHOPS AND CABELA'S \$10K HOLIDAY HAUL CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCES OF ALBERTA, BRITISH COLUMBIA, MANITOBA AND ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of Alberta, British Columbia, Manitoba or Ontario; and
 - (b) be of the age of majority in their province or territory of residence or older at the time of entry.
- 1.2 The following people are not eligible to enter the Contest:

2. CONTEST PERIOD. The Contest begins at 12:00 a.m. Pacific Time ("PT") on October 30, 2023 and ends at 11:59 p.m. PT on November 17, 2023 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. To enter, listen to a Station Monday through Friday, during the Contest Period (excluding statutory holidays), between 6:00 a.m. and 7:00 p.m. for the word of the day (the "Word of the Day") to be announced. No entries will be accepted by any other means.
- 3.2 Limit of one (1) entry per person per Word of the Day. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

4. PRIZES.

- 4.1 There is one (1) grand prize (the "Grand Prize") available to be won by the Grand Prize winner ("Grand Prize Winner") consisting of:

 - (b) One (1) holiday haul prize package valued at two thousand Canadian dollars (CDN \$2,000.00); and
- 4.2 The Grand Prize has an approximate value of ten thousand Canadian dollars (CDN \$10,000.00).
- 4.3 There are one hundred five (105) secondary prizes (each, a "Secondary Prize") available to be won by the Secondary Prize winners (the "Secondary Prize Winners"), each of which consists of a one hundred Canadian dollar (CDN \$100.00) gift card to Bass Pro Shops & Cabela's Canada.
- 4.4 Grand Prize and Secondary Prizes are hereafter collectively referred to as "Prize" or "Prizes".

Grand Prize Winner and Secondary Prize Winners are hereafter collectively referred to as a "Winner" or "Winners".

- 4.5 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.6 Prizes will be distributed within fifteen (15) days after each Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 In the case of event tickets, gift cards or gift certificates, the terms by which the event tickets, gift cards or gift certificates may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.

- 6.1 One hundred five Secondary Prize Winners shall be selected as follows:
 - (a) On each weekday during the Contest Period (excluding statutory holidays), one (1) entrant from each Station will be selected by a random draw from all eligible entries received by that Station during the Contest Period. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.
 - (b) EACH SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL ON THE DAY OF THEIR SELECTION AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION.
- 6.2 One (1) Grand Prize Winner shall be selected as follows:
 - (c) On or about November 20, 2023 in Ottawa, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received from all Stations during the Contest Period. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.
 - (d) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL NO LATER THAN NOVEMBER 21, 2023 AT 9:00 A.M. PT AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION.

- 6.3 Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
